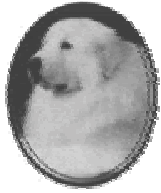
Section 1- Breeder(s) and Owner(s) responsibilities:

BREEDER(S) guarantees that this dog will remain free of any debilitating hereditary defects up to the age of **six (6)** years and furthermore agrees to replace this dog with one of equal value - as determined by the **BREEDER(S)** alone - should any condition develop what would cause this dog to be put down to alleviate pain due to said condition; a second opinion from the Genetics Department of Davis University, Davis, CA (or equivalent in the area where the Owner resides) may be mandatory to determine if the condition is of a hereditary nature should the **BREEDER(S)** deem necessary.

OWNER(S) agrees to maintain this dog in a healthful condition with the dog's welfare in mind, including good grooming and veterinary care as needed. Under no circumstances will this dog be tethered for extended periods of time or remain housed continually in a kennel environment.

OWNER(S) agrees to partake of conformation courses as may be needed and to join a local Great Pyrenees or all breed club recognized by the AKC and to abide by the **Code of Ethics** adopted by The Great Pyrenees Club of America - copy of most current attached; updates will be accepted by all parties herein and will be used for a guideline with regard to acquiring knowledge of the breed and responsibility thereof. It is important that the **OWNER(S)** raise this dog with emphasis on the dog being a good citizen in general and obedience or other training may be necessary.

This dog is being sold as a show prospect, meaning that this dog does not show any outward sign of a defect that would keep it from obtaining its A.K.C. Championship in a reasonable amount of time. To assist in this effort, the **BREEDER(S)** will co-own this dog until completion of its championship. Should the dog develop a defect over time that would keep it from achieving its championship - in the opinion of the **BREEDER(S)** alone- the **BREEDER(S)** agree -upon receiving written notice of dog's spaying/neutering- to replace this dog with another show prospect. The **OWNER(S)** agree to hire a professional handler if it becomes necessary and to aid the dog in competition by maintaining a professional demeanor while showing, including only exhibiting the dog in physically and mentally good show condition.

Section 2 - Breeding Terms:

Should this dog be a **male**, the **BREEDER(S)** retains the right to use him for stud **one (1)** time on any bitch owned by her. The breeding must result in a litter of at least three (3) pups surviving to at least 48 hours old to satisfy this section of the agreement. Should this dog be a **female** the **BREEDER(S)** will not lay claim to any of her puppies as produced by the **OWNER(S)**, however, if it is agreeable by **all parties** the **BREEDER(S)** may select **one (1)** pup from a selected litter which will then satisfy this section of the agreement. **BREEDER(S)** will have the right to have second choice of the selected litter. Neutering or spaying this dog completes this portion of the contract.

Section 3 - Changing Ownership:

It is understood that should situations arise which would make it impossible for this dog to remain with the **OWNER(S)**, the **BREEDER(S)** will have first option to find a new home for said dog. Should this dog be transferred to another party, this agreement will remain intact and be extended in full along with any agreement made between the **OWNER(S)** and the new purchasers and the **OWNER(S)** will inform the **BREEDER(S)** of all new owner information necessary for record keeping.

This is the only agreement, either written or oral, between these parties. Having read and understood all the provisions of this agreement, we hereby agree to the terms set herein.
